

INTRODUCTION

The share of hydro power in the energy sector has declined from about 45% in 1970 to about 18%. Hydro power generation in the country stands at 39788.40 MW against estimated hydroelectric potential of 148701 MW. Even after 66 years of independence we have developed about 27% of available hydroelectric potential. Each five year plan has a target but achievements show dismal picture. Against a target of 14393 MW in 10th plan only 7886 MW could be achieved. 11th plan was no different. Only 5544 MW against target of 15627 MW could be achieved. Big targets have been put for 12th plan as well

Various reasons could be attributed to slow pace of development of hydro capacity potential such as difficult/ inaccessible potential sites and lack of infrastructural facilities like road and communication, land acquisition problems, environment and forest issues, resettlement and rehabilitation problems, law and order problem, paucity of funds, longer gestation period, geological surprises, inter-state aspects, non availability of hydrological data, security restrictions in border areas, lack of adequate skilled manpower and contractual problems. Even ongoing projects are getting delayed for some of the aforesaid reasons. The delay could be about 4 to 5 years or may be more. The delay is eventually leading to cost overruns. A task force on hydro power development headed by the Hon'ble Minister of Power has been set up. Steps are also being taken for expediting project construction as well as for obtaining necessary statutory clearances from various Central Ministries or States for increasing the production of hydropower electricity. Everybody is concerned but outcome is not on expected lines.

Development of hydroelectric potential besides immensely contributing in infrastructure development of the country is a good source of revenue to the states of Himalayan region. It is time that concerted efforts are made to find a way out to deal effectively with the common problems being faced to develop hydropower in the country.

To focus on various issues on the subject, Central Board of Irrigation and Power and Himachal Pradesh Power Corporation Limited, Govt. of Himachal Pradesh proposed to organize a two day conference on the topic "Challenges and Barriers in Hydropower Development" on 18-19 September 2014 at Shimla.
