INTRODUCTION

Indian Power Market is classified into Short Term, Medium Term and Long Term Power Market with the share of approx. 87% of long term transactions in the total electricity transactions in the country. To meet the increasing electricity demand in the country, the electricity generation target (including RE) for 2023-24 has been fixed at 1750 Billion Units (BU) , i.e growth of around 7.2% over the actual generation of 1624 .158 BU for the previous year (2022-23).

The conference will cover the topics of Market Coupling, Ancillary Services, OTC Markets, IEGC Regulations 2023, Green Open Access, Cross Border trade etc. The Conference shall also cover the Emerging Carbon Credit Market in India and the role of cross border trade towards realization of One Sun One World One Grid and way forward in Indian Electricity Markets.
