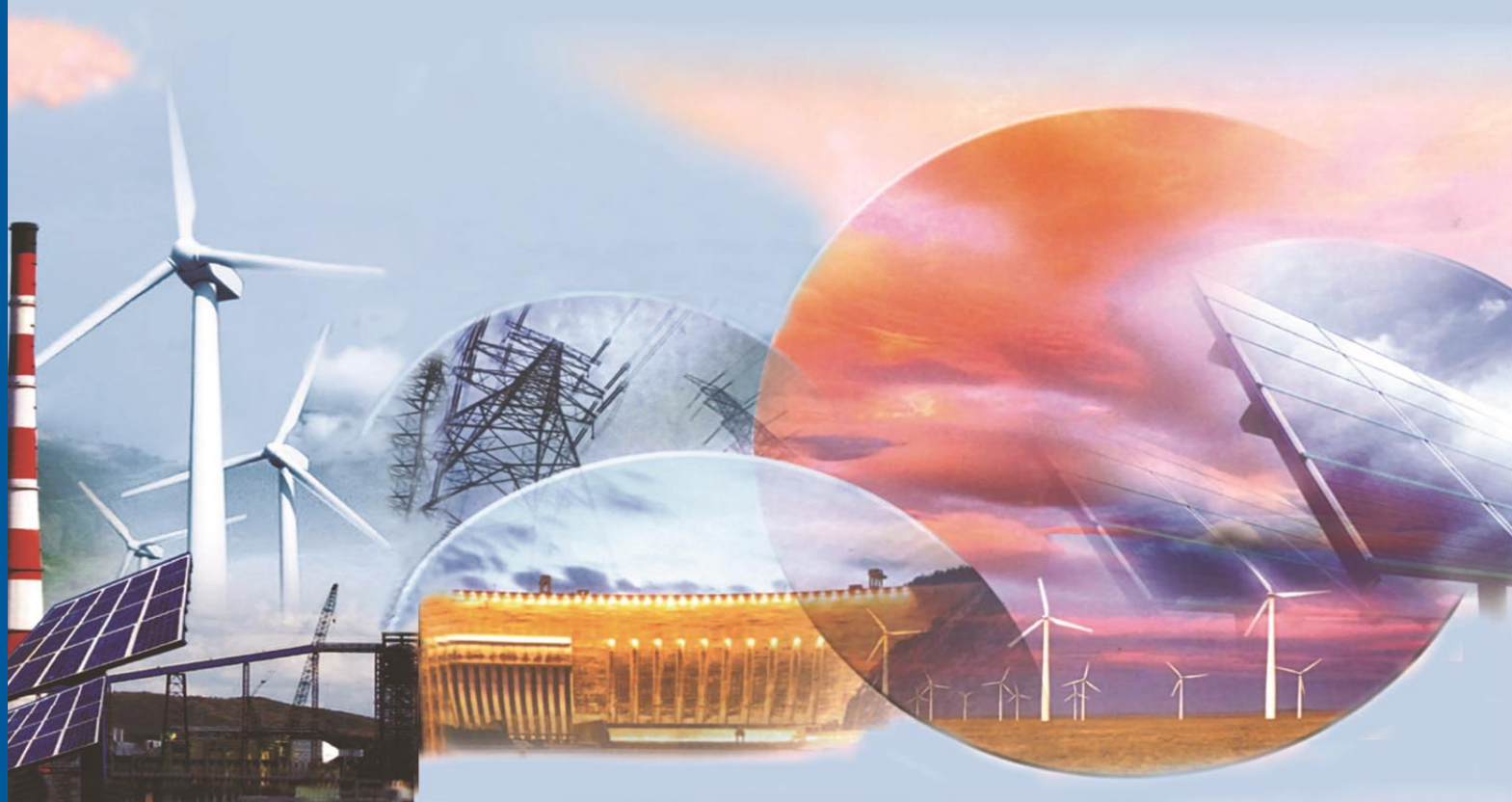

This will only be possible if there is sufficient electricity to power this growth. It is essential that generation capacity is added at a pace matching the growth in demand- and in fact slightly ahead of the demand; so that the shortage of electricity does not slow down growth. Resource Adequacy planning is to play an important role for this.

In view of this CBIP jointly with CIGRE India decided to organise the National Tutorial on Resource Adequacy for Better Power Portfolio Management, on January 16-17, 2025, in New Delhi.
